I also authorize Dance Discovery to automatically charge my account for my monthly tuition on the first of each month, September through the designated ending month in 2010, as well as a costume fee for each class enrolled, and a performance fee per child for the Spring Recital. (Toddler classes will not require a performance fee because their performance will be in the studio.) I understand that these automatic payments may be stopped at any time by speaking with the studio director, Michelle Denny. If I drop a class before the designated end date, I understand that I will only receive a refund for classes that I have not attended 7 days after the date of Director Notification. Billing will stop after 7 days; however, a refund may take up to 30 days to appear in my financial account. The down payment, registration fee, costume fee, and performance fee are nonrefundable. I understand that Dance Discovery has a paperless administration process and the primary mode of contact is via e-mail, which I will not mark as "spam"."
